

22/01030/HOUSE -**Spindlewood, Ermin Street, Woodlands St Mary** – Extension to form new Orangery on side elevation; extension to form new Family Room on rear elevation; and new detached car port with non-habitable room above. Extend Driveway. **Action BJ.**

Note that all the trees and hedges have been removed

Note that the work Commenced in September 2021

Concerns raised over the staircase on the car port and suggest moving it to the other side of the property.

No Objection to the family room and orangery.

22/01007/FUL — **Meridian Stud, Greenways, Lambourn** - The extension of an existing all-weather riding school and a covering to an existing horse walker. **Action IMcK. No Objection, Note that no planning notices are visible at the site.**

At the meeting held on 18 May 2022, Cllr Noll was elected as Chair, with Cllr McKay elected as vice-chair.

At this meeting agreement was reached to refurbish the Old Cricket Field shelter, investigate new signage for Eastbury Furze Park and partial rewilding of the St Michaels and All Angels churchyard. The cemetery regulations will be revamped, and a quick guide created.

Cllr Noll has submitted a Member's Bid to West Berkshire Council for the beautification of Mill Lane. This bid was supported by the Church, the Primary school, Lambourn Junction Cic and local chemist.

The Chair declined to offer a letter of support to the Member's bid

All Councillors should have received my email with a brief update on the recent "Catch Up" exhibitions. I would like to give a public thank you to all those Councillors and parishioners who helped distribute fliers advertising the exhibitions and to those who also attended. We had 104 people sign in and, with those we missed, we think the total attendance was about 120, most of whom heard about the events via the fliers – a communication success! The events were appreciated and there were many thoughtful contributions. The style of event enabled attendees to have quiet and sometimes long conversations with SG members. Comments are being collated.

Core documents, already circulated to Councillors, will be put on the website.

Finances: Locality, the organisation that administers the NDP grants, is no longer providing a £10,000 grant for looking at Affordable Housing for sale. This leaves us £10k short on our estimates. Expenses and fees, as everything else, are rising. We may have another grant source, but the LNDP will be looking at ways we can cover this shortfall.

Timetable: For those who have asked, we hope to have our pre-submission document ready this Autumn, with the final Plan being ready next Spring.
