Noah explained that the Youth Council's goal is to give young people a voice in the village and the means to help the local community.

Lambourn Youth Council has already voted on projects it will undertake. It is not finished yet, however, with its broader plans for what it would like to achieve still emerging, much of which has an environmental focus. One of the Youth Council's biggest concerns is cleaning the river.

They agree water quality needs attention, but they believe that it's also important that they work to remove rubbish from the river as well.

They also intend to set up a movie club where we can have people come and watch a film for a reasonable price. The use of buses is something that they wish to promote. They believe there should be shelters over bus stops so people are more encouraged to take a bus.

The Youth Council's members range in age from eleven to eighteen, and they have a budget of £9,000.00 to undertake their agreed projects.

The Lambourn Youth Council wish to offer their support to the Parish Council in matters relating to the young of the village.

Cllr Jones and Cllr Harris said they would be delighted to work with the Youth Council.

- That although the contracts in isolation may not exceed £25,000.00, as one supplier may bid for all, the Clerk's Office will be obliged under Standing orders 18a to advertise the contracts on the Government Contacts Finder service.
- That the scope of the works was approved at the February 2025 Exceptional Council Meeting and that the Clerk's Office will proceed to seek quotes for presentation to Full Council.
- That the Clerk's Office advises that the total costs resulting from the revisions may exceed those previously paid due to the increased number of cuts and other fundamental changes.
